- (1) to access all future Corporate Communications posted on the Company’s website at www.reginamiracleholdings.com (the “Website Version”), instead of receiving printed copies by mail, and receive a printed notification of the posting of Corporate Communications on the website of the Company; or
- (2) to receive the printed English version of all future Corporate Communications only; or
- (3) to receive the printed Chinese version of all future Corporate Communications only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communications.

In order to increase efficiency in communication with Shareholders and to contribute to environmental protection and for the purpose of saving printing and mailing costs, the Company recommends you to select the Website Version. Otherwise, please affix an appropriate stamp.

If the Company does not receive the duly completed and signed reply form or receive a response indicating the objection from you on or before 14 November 2016 and until you inform the Company c/o the Hong Kong Share Registrar by reasonable notice in writing or by email to reginamiracle.ecom@computershare.com.hk, you are deemed to have consented to read the Website Version in place of receiving printed copies, a printed notification letter of the posting of the Corporate Communications on the website of the Company will be sent to you by post at your address as appearing in the Company’s register of members maintained by the Hong Kong Share Registrar.

You have the right at any time by reasonable notice in writing to the Company c/o the Hong Kong Share Registrar to change the choice of language and/or means of receipt of the Corporate Communications. You may also send such a notice by email to reginamiracle.ecom@computershare.com.hk. Even if you have chosen (or are deemed to have consented) to receive all future Corporate Communications using electronic means but for any reason have difficulty in receiving or gaining access to the Corporate Communications, the Company will promptly upon your request send the Corporate Communications to you in printed form free of charge.
